- * An alien not exempt from the three year alien deeming requirement (see 349.3) must have the sponsor's income and resources deemed (see 352.33). However, if the sponsor's whereabouts are unknown or the sponsor refuses to cooperate or if deemed income is sufficient but not actually available to meet the alien's needs, evaluate the case for HR. If the sponsor actually contributes the deemed amount and it is equal to or greater than the applicant's needs, the contribution is budgeted to meet the applicant's needs and the applicant is ineligible for PA.
- * * IRCA provides SLIAG funding for individuals eligible for HR, PG-ADC or VA for 5 years from the date they are granted LTR status, as long as money is available from HHS.

* * *Form G-641 "Application for Verification of Information from INS Records", when presented by an alien and signed by an INS representative, is considered documentation of lawful admission (see FSSB V-B-3.11).

* * * * Permanently Residing in the U.S. Under Color of Law (PRUCOL)

Whether an alien is PRUCOL for public assistance purposes is predicated on evidence confirming two factors:

- 1. An official determination by the Immigration and Naturalization Service (INS) that an alien is legitimately present in this country; and
- 2. A determination that this alien is legitimately present for an indefinite period of time.

Aliens in the following status categories are considered to be PRUCOL. Please note that this list is not all inclusive.

- ‡+ 1. Refugees per Section 207(c) of Immigration and Naturalization Act (INA).
 - + 2. Political asylees per Section 208 of INA.
 - + 3. Aliens granted temporary parole status per Section 212(d)(5) of INA.
- ‡ + 4. Cuban/Haitian Entrants per Section 212(d)(5) of INA.
 - 5. Aliens under an INS Order of Supervision per Section 242(d) of INA.
 - 6. Aliens granted an indefinite stay of deportation.
 - 7. Aliens granted an indefinite voluntary departure status per Section 244 of INA.
 - 8. Aliens granted a voluntary departure status per Section 242(b) of INA.
 - 9. Aliens granted deferred action status.
 - 10. Aliens granted suspension of deportation per Section 244 of INA.
- +11. Aliens who have resided continuously in the U.S. prior to 1/1/72 per Section 249 of INA.
 - 12. Cubans or Haitians granted Lawful temporary resident status per Section 201 or 302 of INA.
 - 13. Aliens granted voluntary departure status when an immediate relative petition has been approved by INS.
- ± 100% Federal funding for HR/PG-ADC for 8 months from date of entry into the U.S.
 - Possible enriched federal funding for ADC for 4 months from the date of entry into the U.S.
 - Federal Charge Codes: 30 Refugees
 - 34 Cuban Entrants
 - 36 Haitian Entrants
- + Aliens granted this status are eligible for Food Stamps.
 - In addition, an alien living within the U.S. for whom the Attorney General withheld deportation pursuant to Section 243(h) of INA is eligible for Food Stamps.
