

**TEMPORARY ASSISTANCE**

**Chapter 20 - Eligibility for Child Assistance**

[Assembly 7165 by Assemblyman Ramirez]

Provides that persons eligible for both the Child Assistance Program and the Medical Assistance Program (MA) who lose eligibility for MA solely due to increased earnings or loss of earned income disregards will remain eligible for MA until March 31, 2000.

**Chapter 201 - Standard of Monthly Need, Personal Needs Allowance**

[Senate 5837 by Senator Meier, at the request of the Office  
of Temporary and Disability Assistance]

Increases the standards of monthly need for determining eligibility and payment of federal Supplemental Security Income (SSI) and additional State payments to the aged, blind and disabled to reflect SSI benefit increases that may result from any cost-of-living adjustment occurring between January 1, 2000 and June 30, 2000 and makes corresponding changes to personal allowances provided to residents of congregate care facilities.

**Chapter 389 - Automobile Exemptions**

[Senate 5850 by Senator Meier, et al.]

Increases in certain circumstances the value of an automobile that a recipient of public assistance can own without affecting the recipient's eligibility for public assistance. Specifically, the Chapter provides that if the automobile is needed to enable the recipient to seek or retain employment or to travel to or from work activities, the automobile's value can be up to twice the value of an automobile that can be exempted from consideration in determining eligibility for food stamps, or a higher amount as determined by the social services district.

**Chapter 391 - Child Care Subsidies**

[Assembly 996-B by Assemblywoman Jacobs, et al.]

Requires social services districts to provide child care subsidies to working public assistance applicants and recipients who, although eligible for public assistance, elect to receive only child care subsidies. The Chapter also provides that recipients of child care subsidies who are no longer eligible for public assistance are eligible for transitional child care.

**Effective date:** January 23, 2000

**Chapter 407 - Earned Income Tax Credits**

[Senate 6110 by the Committee on Rules]

Authorizes the Department of Taxation and Finance to furnish to the Office of Temporary and Disability Assistance information relating to the payment of the earned income tax credit to the extent necessary for the Office to calculate qualified State expenditures or to document the proper expenditure of federal temporary assistance for needy families funds.

**Chapter 513 - Family Loan Programs**

[Senate 5848 by Senator Meier, et al.]

Requires the Department of Labor, in consultation with the Office of Temporary and Disability Assistance, to establish up to four new family loan programs. Such programs provide administrative startup monies for not-for-profit organizations or local governments to administer revolving loan funds. The funds are provided to custodial parents with income below 200 percent of the federal poverty level and who are working or enrolled in a post-secondary education program to aid in covering the costs of unexpected expenses that could interfere with their ability to maintain employment or continue their education.

**Chapter 514 - Additional State Payments for Persons in Rockland County**

[Senate 5863 by Senator Morahan]

Adds Rockland County to a list of municipalities in residents of family care homes and residential care facilities are paid a higher level of State supplementation of federal Supplemental Security Income benefits than residents elsewhere in the State.

**CHILD SUPPORT**

**Chapter 139 - Enforcement of Child Support Orders**  
[Assembly 7698 by Assemblywoman Weinstein, et al.]

Extends from June 30, 1999 until June 30, 2001 the expiration date of the authority for the referral to the Department of Taxation and Finance for enforcement of non-payment of child support.

**Chapter 140 - Drivers' Licenses Suspension**  
[Assembly 7699 by Assemblywoman Weinstein, et al.]

Extends from June 30, 1999 until June 30, 2001 the expiration date of the authority for the administrative suspension of drivers' licenses for non-payment of child support.

**Effective date:** June 29, 1999

**Chapter 533 - Support Orders**  
[Assembly 7708 by Assemblywoman Weinstein]

Provides that modifications of a child support order issued in another state may be made only as authorized by the Uniform Interstate Family Support Act; corrects statutory cross-references found in various sections of the Family Court Act (FCA); conforms genetic testing language contained in the FCA to amendments made by Chapter 398 of the Laws of 1997; and provides that a medical execution for child support cases not receiving services under Title IV-D of the Social Security Act must be in the form of a separate qualified medical support order.
