

TEMPORARY ASSISTANCE

Chapter 111 - Additional State Payments
[Assembly 6588 by Assemblywoman Jacobs, et al.]

Extends for one year the State's assumption of responsibility for payment of the social services districts' share of the costs of additional State payments to Supplemental Security Income recipients.

Chapter 189 - Standard of Monthly Need, Personal Needs Allowance
[Assembly 7602 by the Committee on Rules]

Increases the standards of need for determining eligibility and payment of federal Supplemental Security Income (SSI) and additional State payments to the aged, blind and disabled to reflect SSI benefit increases that may result from any cost-of-living adjustment occurring between January 1, 1998 and June 30, 1998.

Chapter 436 - Welfare Reform/Restructuring of the Department
of Social Services
[Senate 5788 by the Rules Committee]

Implements provisions of the Federal Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (P.L. 104-193). Specifically, the Chapter: (i) abolishes the Aid to Dependent Children and Home Relief Programs and establishes a new Family Assistance Program and a Safety Net Assistance Program; (ii) establishes residency requirements in order to obtain public assistance benefits; (iii) establishes public assistance eligibility requirements for aliens; (iv) establishes time limits for the receipt of public assistance; (v) establishes new work rules and training requirements in order for persons to be eligible for public assistance; (vi) establishes a new child assistance program; (vii) establishes drug and alcohol screening requirements for applicants for and recipients of public

assistance; (viii) authorizes the payment of performance awards to social services districts that have achieved performance goals; (ix) exempts certain persons subject to domestic violence from residency requirements, child support cooperation requirements and employment and training requirements in order to be eligible for public assistance; (x) establishes a block grant for child care; (xi) establishes an electronic benefit transfer system; and (xii) authorizes social services districts to operate a food assistance program.

In addition, the Chapter restructures the Department of Social Services into the Department of Family Assistance with an Office of Children and Family Services and an Office of Temporary and Disability Assistance.

Authorizes the Department of Labor, in consultation with the Office of Temporary and Disability Assistance, to solicit proposals to establish family loan programs. Such programs would make small, no-interest loans to

custodial parents whose income does not exceed 200 percent of the Federal poverty level and who are working or enrolled in a post-secondary education program.

Chapter 271 - Domestic Violence Information

[Senate 1023-A by Senator Skelos]

Requires hospitals providing maternity services and diagnostic and treatment centers providing pre-natal services to furnish to parents of newborn infants information concerning family violence upon discharge from the hospital or at the first pre-natal visit.

Provides for the continuity of law guardian representation for children in foster care proceedings, including proceedings to extend the foster care placement of children, and proceedings involving the periodic court review of children who have been freed for adoption.

Requires the Commissioner of Labor to assist the Office of Prevention of Domestic Violence in the creation, approval and dissemination of a model domestic violence employee awareness and assistance policy to be implemented on a voluntary basis by businesses and other private institutions.

Chapter 375 - Adoption Proceedings

[Senate 5164 by Senator Saland, et al., at the request of the Judiciary]

Deletes the provision that dispenses with the need to obtain the consent for the adoption of a child from a person who has executed and properly recorded an irrevocable instrument consenting to the other parent's surrender of the child or consent to the child's adoption; clarifies that an adoption proceeding involving a foster child whose guardianship and custody has been surrendered to an authorized agency is exempt from the venue provisions that require an adoption petition to be filed in the county where the adoptive parents reside or where an authorized agency has its principal place of business; and provides that a court may grant an order of adoption in a private adoption when the child has been in the adoptive parents' home for at least three months.

Chapter 402 - Task Force on School-Community Collaboration

Clarifies and expands the role of the Task Force on School-Community Collaboration. The purpose of the Task Force is to improve working relationships between and among schools, health, mental health and social services providers and agencies, youth bureaus, youth employment programs, local probation departments and other State and local human services agencies.

Clarifies that appeals from family court orders must be taken no longer than 30 days after service of the order by a party or the law guardian upon the appellant, 30 days from receipt of the order by the appellant in court or 35 days from the mailing of the order to the appellant by the clerk of the court, whichever is earlier. Also requires that the order contain a statement of the time periods for taking an appeal from a family court order.

Expands the programs and facilities required to clear through the State Central Register of Child Abuse and Maltreatment prospective employees and providers of goods and services to the program or facility. The additional programs and facilities include non-residential programs licensed or operated by the Office of Mental Health or the Office of Mental Retardation and Developmental Disabilities, early intervention services established pursuant to section 2540 of the Public Health Law, pre-school services established pursuant to section 4410 of the Education Law and programs and facilities licensed by the Office of Alcoholism and Substance Abuse Services.

Requires police agencies to report to the Division of Criminal Justice Services (DCJS), on at least a semi-annual basis, information concerning closed cases involving missing children; authorizes taxpayers to make contributions to the Missing and Exploited Children Clearinghouse Fund by using their income tax return form; and requires DCJS to submit an annual report to the Governor and the Legislature that contains statistical information involving reported cases of missing children and a summary of the Division's efforts with respect to the use of the monies from the Missing and Exploited Children Clearinghouse Fund.

Requires that the New York City Department of Investigation or other New York City investigating agency conduct a criminal history record check on applicants for employment in a position providing child day care services and contracts to provide day care services.

Removes the provision limiting to four the number of children under two years of age that may receive care in a group family day care home. Requires that each group family day care home have at least one caregiver for every two children under two years of age. Clarifies that local governments may not prohibit the use of residential dwellings for family day care homes. Provides greater flexibility to operators and directors of family day care homes, small day care centers and school-age child care programs in selecting the topics for their required on-going training. Allows all licensed or registered day care providers to use a child care resource and referral program's list of substitute child caregivers.

CHILD SUPPORT

Chapter 397 - Non-Support of a Child

[Senate 5356-A by Senator Saland, et al., at the request of the Governor]

Provides for a class E felony where a parent or guardian legally charged with the care or custody of a child under the age of 16 is convicted for a second time, within five years, of failing to provide support to the child.

Chapter 398 - Child Support Enforcement

[Senate 5771 by Senator Saland, et al., at the request of the Governor]

Implements requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (P.L. 104-193) by adopting the Uniform Interstate Family Support Act, establishing a computerized State case registry and improving the State's new hire reporting program. The Chapter also gives the State and local child support agencies additional tools and remedies to establish paternity and establish and enforce child and spousal support orders, including new administrative procedures and the increased use of automation. The Chapter also establishes a cost of living adjustment process to ensure that child support orders keep pace with inflation.
