The purpose of this Informational Letter is to introduce the new IDSS-4579: "Alien Status Desk Guide" (Rev.2/98) (copy attached).

This desk guide contains Alien Status program eligibility requirements under the federal "Personal Responsibility and Work Opportunity Reconciliation Act" (August 1996) and the "New York State Welfare Reform Act of 1997".

The IDSS-4579: "Alien Status Desk Guide" (Rev.2/98) has been developed to assist staff in identifying appropriate alien status as established under the federal Immigration and Nationality Act and to relate that status to individuals' eligibility for Public Assistance, Food Stamps and/or Medicaid.

The IDSS-4579 replaces the initial Alien Status chart that was distributed at the May 8, 1997, Alien Status Teleconference and similar desk guides used for training purposes. It includes one recent change whereby an alien lawfully admitted for Permanent Residence, who has 40 qualifying quarters of Social Security Coverage can, if otherwise eligible, receive Food Stamps without regard to date of entrance.

The revised State policy regarding alien eligibility status was issued in 97 ADM-23, "Public Assistance (Family Assistance/Safety Net Assistance) Changes Resulting from the Welfare Reform Act of 1997". Related MA eligibility was also addressed in this ADM. Food Stamp policy for aliens was issued in 97 ADM-25, "Food Stamp Eligibility of Non-Citizens". Additionally, Regional Meetings were conducted to provide information for implementation of the new requirements of the Welfare Reform Act, including alien eligibility status.

The new desk guide will be printed on green cardstock and should be delivered to the Albany and NYC/HRA Warehouses sometime in May, 1998. Local districts will automatically receive initial supplies of this form.
