For General Information...

For basic biographical information, start with the American Medical Association's site. Click on "Doctor Finder," which will take you to the AMA's "Physician Select." You can search by the provider's name or his/her medical specialty. If you don't see his/her specialty listed, click for an expanded list of medical practice specialties. The site lists both AMA and non-AMA members who are either MDs or DOs (Doctors of Osteopathy, or osteopaths). You must have the provider's last name and state or zip code. However,

you can use a * as a wild card character for the first name and you can check a box for a "sounds like" search. A successful search will list the provider's medical (or osteopathic) school and year of graduation, location and type of residency training, and major professional activity (for example, office-based practice).

For DOs, go to the American Osteopathic Association's site. Click on "Find a D.O." The advanced search engine allows for searches by name (last or first), city, state, zip code, primary specialty or type of practice. The resulting AOA Yearbook & Directory entry lists the provider's osteopathic school and year of graduation, and podiatrists. Be sure to select a

primary specialty and AOA board certification.

For dentists, look at the American Dental Association's site. Click on "Find a Dentist." The ADA member directory's search criteria include name (last and first), city, state, zip code, and specialty (general practice, surgery,

periodontics, etc). There also are links to state and local dental societies such as the New York State Dental Association.

For Licensing...

To confirm that the provider is licensed to practice in New York State, go to the New York State Education Department's Office

of the Professions site. You can search by the provider's name or license number. You can use this site to look up other health professionals, such as acupuncturists, Certified Social Workers (CSWs), chiropractors, dentists, Nurse Practitioners (NPs), occupational therapists (OTs), physical therapists (PTs),

For Board Certification...

Go to the American **Board of Medical** Specialties site (Note: Registration is required). ABMS is an organization of 24 approved medical specialty boards, covering: allergy & immunology, anesthesiology, colon & rectal surgery, dermatology, emergency medicine, family practice, internal medicine. medical genetics, neurological surgery, nuclear medicine. obstetrics & gynecology, ophthalmology, orthopedic surgery, otolaryngology, pathology, pediatrics, physical medicine & rehabilitation, plastic surgery, preventive medicine, psychiatry & neurology, radiology, surgery, thoracic surgery

and urology. The ABMS medical specialty list is alphabetical with links to the Boards' sites.



For Professional Misconduct and/or Medical Malpractice...

First, go to the New York State Department of Health's Professional Misconduct & Physician Discipline site. According to this site, the Office of Professional Medical Conduct (OPMC) "is responsible for investigating complaints about physicians, physician assistants, and specialist assistants. The Office also monitors practitioners who have been placed on probation." This site has information from 1992 on. Click on "Physician Search." The search requires name, license number (if you do not know, click on "License

Number Look-up"), license type, effective date, and etc. Wild card characters can be used for name and license type and you can specify a search based on any or all of the criteria. The "successful" search will



list the effective date of OPMC's action, a description of their action, and a description of the misconduct. An example (familiar to many DAPers), consultative examiner Dr. Peter Graham: as of April 2, 1996, his license was suspended for 2 years, stayed with probation for 2 years with provision of emergency

services only under supervision.

Education, Practice Info, Legal Actions, Professional Activities, and Statement. Within each of these categories are subcategories: for example, Legal Actions comprises Malpractice, NY Licensee Actions (which links to OPMC), Out-of-State Actions, Current Limitations, Hospital Restrictions and Criminal Convictions.



Again using Dr. Graham: as of a September 13, 2002 update. under Hospital Restrictions. "emergency services can only be performed under supervision in emergency room setting" in New York.

In addition, take a look at the New York State Physician Profile site. This site has profiles of all MDs and DOs registered to practice in New York State. There are links to language translation in Chinese, Haitian Creole, Russian and Spanish. You need at least one of the following: last name, first name, field of medicine, hospital, county or borough, or city, town or village. Depending on the provider, the search might include these categories:

One Fee-Based Search Engine...

Knowx.com "provides instant access to comprehensive public record information." Under the professional license category, searches are available for chiropractors, dentists and physicians. Returning to Dr. Graham, Knowx found a match but wanted \$9.95 "to purchase details."

Microsoft Revises Product Support Policies

On October 15, 2002, Microsoft published a new policy regarding the support of its software products. Under the previous policy, Microsoft could drop support on any date of a product's general availability. product after giving customers six month's notice. Most customers felt that they had been placed in a very awkward position, never knowing how long a product would be supported and/or not necessarily having funds in the budget to purchase an upgrade. It has been reported that as many as 2/3 of customers refused to purchase the discounted upgrades within

the 6-month time period. They continued to use unsupported software and then either purchased product upgrades from Microsoft at full price or switched to a product offered by one of Microsoft's competitors.

Under the new policy, Microsoft **Business and Software**

Development Products will be supported for five years from the date of release. That support includes all the support options and programs that customers receive today, such as no-charge incident support, paid incident support, support charged on an hourly basis, support for warranty claims, and hotfix support. For support beyond the initial five years, companies can purchase up to two additional years of extended support that could include assisted support (charged on an hourly basis) and hotfix support. Microsoft will also make self-help online support available via the Internet for at least eight years.

For Consumer/Hardware/Multimedia Products. Microsoft will offer a minimum of five years of mainstream support from the Product's with a new version released annually (for example, Money, Encarta, Picture It!, Streets & Trips) will receive a minimum of three years of mainstream support from their date of availability. Additionally, most products will receive at least eight years of online self-help support.

Realistic Product Lifecycles

Under this new plan, users can plan on how long a product can be used. Many products that were to be phased out in the near future have been given a reprieve. Listed below are some of the most commonly used Microsoft operating systems and

products:
